

TERM & CONDITIONS

1. Quoted Rates are in a Standard Room and Single Rate Supplement (where not mentioned), or Non-Residents Rates Supplement May Apply in Some Instances. As well Child Policies apply and Ages Differentiate from Facility to another
2. 50% of the Amount is Payable for Booking Confirmation and Full Payment 48 Hrs Before Check in to the Hotel
3. Payments are Accepted by either Cash, Credit or Debit Card (**Any Credit or debit Card Transaction will therein Accrue 3.5% as Bank Charges on Top of the Total Cost on The Quote**) Cheques (**Cheques Can Only be Accepted 7 Working Days Prior to the Travel Date**) MPESA or Airtel Money Transaction
4. Credit will be Withheld (*Note that Oribi Expeditions Operates on a Non-Refundable Policy*) if cancellation or changes occurs in writing 70 Days Prior to Commencement of Safari. Credit Withheld on all Pre-Paid Money will be based on Cancellation fees levied by hotels and lodges. Generally, there is a 50% Charge on Cancellation within 30 Days, 75% Charge within 7 Days, and 100% Charge 48 Hours. Oribi Expeditions reserves the Right to deduct all expenses incurred from the Money Paid. Some Services are Non-Creditable and only arrangement from our End Partners (Flights, Travel Insurance) with agreeable workings can be Withheld as Such
5. Specific Request such as adjacent or Connecting room bedding requests, smoking room and special dietary needs should be advised at time of booking. note that effort made to secure a special request, however cannot be guaranteed.
6. All Government taxes and service charges as levied by hotel are included. Gratuities are however not; these are at the guest discretion.
7. Oribi Expeditions doesn't assume Liability or indemnify the guest herein during Adventure Experiences or Loss during Travel, unless by virtue of purchase of Travel Insurance covering details as stated on the Specified Insurance Policy.
8. Care must be Taken with Owners (Host Hotels, Rentals, Homes) Properties and Possessions which Should be left in the Conditions they were found and Breakages must be Reported and at Times
